12-03-2024 SWFPD Meeting Draft Minutes

Call to Order: 8:31

Roll Call: President Striegler, Vice President Heivly, Board Member Spitz, Board Member Arthur, Treasurer Boineau, Chief Thompson, Deputy Chief Issel, HR Director Thomas, Finance Director J Thompson, IT Director Johnson, Secretary Diamond, Deputy Fire Marshal Stott, Fire Marshal Mele.

Approval of Minutes: Board Member Spitz motioned to approve the minutes from 10/15/24; Treasurer Boineau seconded the motion. There was no discussion, and the motion passed, and none opposed.

Chief Report: Chief Thompson told the Board of a Holland Hills structure Fire where no injuries occurred, and they stopped loss in the roof of the house two weeks ago. Chief Thompson said we received mutual aid from Aspen Fire, Aspen Ambulance, and Carbondale Fire.

Finance Report:

Finance Director Thompson told the Board the total amount was 9.989, a little higher than in 2023 due to the Gallagher adjustment.

- -Finance Director Thomson said Resolution 7 summarizes the expenditures and revenues of the actual budget.
- -Vice President Heivly motioned to accept Resolution 7. Board Member Spitz seconded the motion. All Board members favored passing Resolution 7, and none opposed it.
- -Finance Director Thompson said Resolution 8 appropriates the sums for each budget behind the general fund expenditures. Finance Director Thompson noted the general fund expenditures are 6295. Finance Director Thompson said the debt service payment principle and interest next year is at 1.23765. Finance Director Thompson told the Board to anticipate \$680,000 coming from the capital fund. Finance Director

Thompson said the pension fund went down due to the passing of two retirees last year; it went down to 42,770.

—Treasurer Boineau motion to accept Resolution 8. Board Member Spitz seconded the motion. There was no discussion, and all favored passing Resolution 8.

Director Thompson said Resolution 9 is the requirement for levying the taxes for Pitkin County. Finance Director Thompson noted that the operation account is 7.789 broken down, and 1.2 mills will be collected to satisfy our obligation debt.

-Treasurer Boineau motioned to accept Resolution 9. Board member Arthur seconded the motion. All Board Members favored passing Resolution 9. None opposed, and there was no discussion.

-Finance Director Thompson reviewed with the Board the documents sent to Pitkin County, a new document submitted for House Bill 123, which our attorney helped with. Finance Director Thompson said the informational piece goes to Dola. Discussion:

SWFPD Pension Update:

The current pension account remains sound. \$50,000 was allocated in 2024 and will again be allocated to be transferred into the pension account 2025. The information for 2024 audit has been submitted and the report will be available for the auditors. All 1099's have been mailed out to pension recipients.

SWFPD Election Information:

Snowmass has 3 (three) seats up for election in 2025. Ellie Striegler, Scott Arthur and Bethany Spitz are all up for 4-year terms. If an election is called for, it will be a mail-in ballot election. B&RFPD Election Information:

Basalt has 3 (three) seats up for election in 2025. Ed Van Walraven, John Young and Vonda Williams are all up for 4-year terms. If an election is called for, it will be a mail-in ballot election. I have included the Resolution naming myself as the Designated Election Official and notifying the election date of May 6, 2025. The Call for Nominations has been posted in The Aspen Times per statute as well as on the website. Self-Nomination forms are available at Station 42 and will be accepted until the close of business February 28,2025 @ 4:30 p.m.

RFFRA Update:

I have begun the task of closing out 2024 for all 3 entities. The audit has been scheduled for May so I have a little bit more time to prepare this year. W-2's are almost complete and will be sent out both electronically and by mail this week.

RFFRA budget appears to be coming in under budget at 90% overall and 95% in operations. I am continuing to monitor our wildfire revenue as we still have \$363,748.35 outstanding. The billing has all been completed on my end, the delay is with the Colorado Division of Fire Prevention and Control. Many are Districts have run into the same delay and everyone is hoping this is resolved as quickly as possible. Including the delayed wildfire revenue, the Authority collected and additional 12% of revenue over the budgeted numbers. The budgeted revenue was \$12,231,195, and the revenue collected was \$13,699,385 which add an additional \$1,468,190 to the Authority revenue.

RESOLUTION NO. 2, SERIES OF 2025

A RESOLUTION CALLING FOR THE 2025 REGULAR DISTRICT ELECTION AND APPOINTING A DESIGNATED ELECTION OFFICIAL

WHEREAS, the Snowmass-Wildcat Fire Protection District (the "District") is a quasimunicipal corporation and political subdivision of the State of Colorado and a duly organized and existing special district pursuant to Title 32, Article 1, C.R.S.; and

WHEREAS, the terms of office of Directors Elizabeth Striegler, Bethany Spitz, and Scott Arthur shall expire after their successors are elected at the regular special district election to be held on May 6, 2025 (the "Election") and have taken office; and

WHEREAS, in accordance with the provisions of the Special District Act (the "Act") and the Colorado Local Government Election Code (the "Code") (the Act and the Code being referred to jointly as the "Election Laws"), the Election must be conducted to elect three (3) Directors to serve for a term of four (4) years.

NOW, THEREFORE, be it resolved by the Board of Directors of the Snowmass-Wildcat Fire Protection District in the County of Pitkin, State of Colorado that:

- 1. The regular election of the eligible electors of the District shall be held on May 6, 2025, between the hours of 7:00 a.m. and 7:00 p.m. pursuant to and in accordance with the Election Laws, and other applicable laws. At that time, three (3) Directors will be elected to serve a four-year term.
- 2. The Election shall be conducted as a mail ballot election in accordance with all relevant provisions of the Code. The Designated Election Official shall develop a Plan for conducting the mail ballot Election, which will be made available to the public. There shall be no election precinct or polling place. All mail ballots shall be returned to the Designated Election Official's office.
- 3. The Designated Election Official may change the voting procedure from mail ballots to a polling place at the discretion of the Board of Directors. In the event that the voting procedure changes to a polling place, the Designated Election Official must follow all relevant provisions and notice requirements of the Election Laws.
- 4. The Board of Directors hereby designates Jennifer Thompson as the Designated Election Official for the conduct of the Election on behalf of the District and she is hereby authorized and directed to proceed with any action necessary or appropriate to effectuate the provisions of this Resolution and of the Election Laws or other applicable laws. Among other matters, the Designated Election Official shall provide the call for nominations, appoint election judges as necessary, appoint the Canvass Board, arrange for the required notices of election, printing of ballots, and direct that all other appropriate actions be accomplished.

- 5. Self-Nomination and Acceptance forms are available from the Designated Election Official at 1089 JW Drive, Carbondale, Colorado, or email jthompson@roaringforkfire.org. All candidates must file a Self-Nomination and Acceptance form with the Designated Election Official no earlier than January 1, 2025, nor later than the close of business on Friday, February 28, 2025.
- 6. If the only matter before the electors is the election of Directors of the District and if, at the close of business on March 4, 2025, there are not more candidates than offices to be filled at the Election, including candidates timely filing affidavits of intent no later than March 3, 2025, the Designated Election Official shall cancel the Election and declare the candidates elected. Notice of such cancellation shall be published and posted in accordance with the Code.
- 7. If any part or provision of this Resolution is adjudged to be unenforceable or invalid, such judgment shall not affect, impair, or invalidate the remaining provisions of this Resolution, it being the Board's intention that the various provisions hereof are severable.
- 8. Any and all actions previously taken by the Designated Election Official, the Secretary of the Board of Directors, or any other persons acting on their behalf pursuant to the Election Laws or other applicable laws, are hereby ratified and confirmed.
- 9. All acts, orders, and resolutions, or parts thereof, of the Board which are inconsistent or in conflict with this Resolution are hereby repealed to the extent only of such inconsistency or conflict.
 - 10. The provisions of this Resolution shall take effect immediately.
